

INVESTMENT STRATEGY

The investment objective of the Fund is to achieve a persistent return with a low level of volatility over the long term and thus to overhaul the rate of inflation and returns on bank deposits in the long run. For this purpose, the Fund invests mainly in high-quality corporate bonds from issuers from the Czech Republic, supplemented by issuers from the EU and possibly other countries, in money market instruments, reverse repo operations and other fixed income instruments. To ensure stability, the fund will use hedging of exchange rate risk against CZK, or interest rate risk using financial derivatives. Current coupons are reinvested and are further appreciated. The Fund does not actively track any index or benchmark.

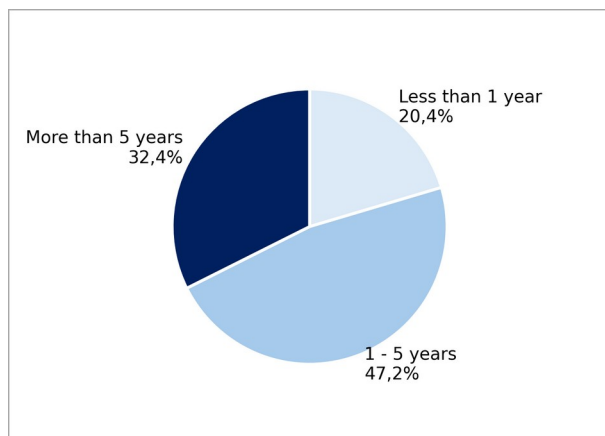

PORTFOLIO MANAGER'S COMMENTARY

The Fund's unit price rose 0.31% last month, translating to an annual return of 3.9%. The portfolio's coupon income again supported returns. European and Czech government bond and credit markets in June absorbed the first interest rate hikes by the ECB and the CNB for 3 and 4 years, respectively. Both Central Banks moved their policy benchmarks up 25bps (0.25%) reacting to the probability of higher inflation in the second half of 2026 and into 2027. June's actual consumer price inflation readings were benign, though, with the Eurozone print at 2.8% year-on-year and the Czech figure at just 1.5%. Food and energy price hikes are expected in coming months, especially after the renewal of hostilities in the Gulf in July. The portfolio remains positioned to absorb these risks through our interest rate swap hedging positions and our holdings in the energy sector, which amounts to 30% of the NAV at present. With a gross yield-to-maturity of 5.7%, the Fund offers investors a healthy return versus current and likely inflation rates in the near to medium term.
