

INVESTMENT STRATEGY

The investment objective of the Fund is to achieve a persistent return with a low level of volatility over the long term and thus to overhaul the rate of inflation and returns on bank deposits in the long run. For this purpose, the Fund invests mainly in high-quality corporate bonds from issuers from the Czech Republic, supplemented by issuers from the EU and possibly other countries, in money market instruments, reverse repo operations and other fixed income instruments. To ensure stability, the fund will use hedging of exchange rate risk against CZK, or interest rate risk using financial derivatives. Current coupons are reinvested and are further appreciated. The Fund does not actively track any index or benchmark.

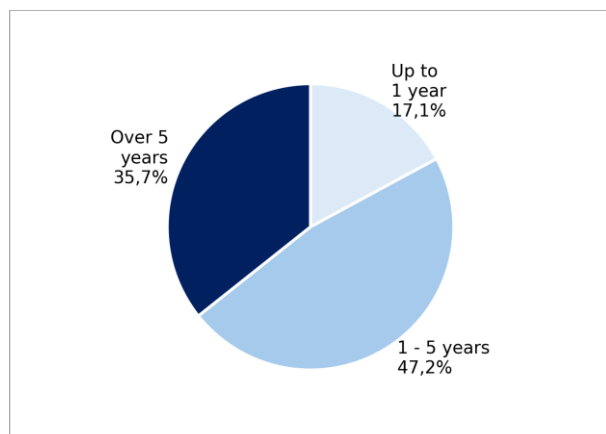

PORTFOLIO MANAGER'S COMMENTARY

The traditionally slow August month allowed credit markets worldwide to stabilize after July's volatility. The Fund's NAV rose 0.33%, largely reflecting the coupon income received from bonds held in the portfolio. Eurozone and Czech government bond markets continued to price in the prospect of future higher inflation and interest rates. Neither the ECB or the CNB hiked policy rates in their latest meetings but may well do so in September. August's Eurozone consumer price inflation rose to 3.3% year-on-year, while the corresponding Czech figure edged up to 1.9%. We remain positioned for an unfolding volatile environment through diversified issuer exposure, large energy-sector holdings and interest-rate swap hedging, which reduce sensitivity to further benchmark yield increases. The Fund's gross yield-to-maturity of 5.83% points to a potential annual return that remains attractive relative to both current and expected inflation and bank deposit rates. We bought Uniqa Insurance's 2036, CPI's 2032 and Moneta Money Bank 2031-refix bonds in August. These purchases took the total number of holdings to 70.
